SUBJECT: Virginia Military Survivors and Dependent Education Program – Annual

Report

Pursuant to state law, SCHEV provides the following data collection on 2025-26 usage of the Virginia Military Survivors and Dependent Education Program (VMSDEP) and report summarizing the findings.

<u>Chapter 371</u> requires the following:

1. § 1. That the State Council of Higher Education for Virginia shall, in coordination with the Department of Veterans Services, submit to the Senate Committee on Finance and Appropriations and the House Committee on Appropriations by November 1 of each year a report on (i) the number of individuals who are qualified survivors and dependents, as that term is defined in § 23.1-608 of the Code of Virginia, and have been certified as eligible for participation in the Virginia Military Survivors and Dependents Education Program (the Program) but are not yet admitted to a public institution of higher education in the Commonwealth and (ii) the best available estimate of the total number of qualified survivors and dependents, as that term is defined in § 23.1-608 of the Code of Virginia, who are participating in the Program and enrolled in the fall semester at each public institution of higher education in the Commonwealth.

In compliance with the above requirement, the Department of Veteran's Services (DVS) reports a total of 7,293 qualified beneficiaries not enrolled in Fall 2025. Of this total, 6,783 who were enrolled previously but are not enrolled in Fall 2025 and 510 who have never used the VMSDEP benefits and are not enrolled in Fall 2025. SCHEV surveyed the public institutions which report a total of 10,784 VMSDEP recipients in Fall 2025.

Prior to 2018-19, the VMSDEP Tuition Waiver program was relatively stable as it provided full tuition and required fee waivers to dependents of qualifying service veterans. In 2019, the eligibility requirements for VMSDEP requirements changed with the passage of SB1173 and the value of the tuition waivers grew from \$12.0 million in 2018-19 to \$19.4 million in 2019-20. Following another change to the program in the 2020 session of the General Assembly (SB768), the value of the waivers increased again in 2020-21 to \$31.3 million.

While there were no further legislative changes after 2020, there are anecdotal reports of increased

2019 – <u>SB1173</u>: Expanded program eligibility to include those whose injuries were work-related though not combatrelated.

2020 – SB768: Expanded program eligibility to include stepchildren of qualifying deceased military service member and DVS authority to consider dependents of qualifying military members who passed prior to fulfilling the five year residency.

program awareness provided by various veteran service providers and a suggestion of an increase in eligible recipients stemming from the Global War on Terror (GWOT) and related actions that began 19 years prior. Finally, as tuition and fee charges increase, the total value of these waivers also continues to grow.

Table 1 provides the incremental usage and growth of the program since 2018-19. The annual values represent the final official number of unique recipients and the total value of the tuition and fee waivers for years 2018-19 through 2023-24. The values for 2024-25 represent the preliminary end of year numbers provided by the institutions. These numbers become final after SCHEV completes its end-of-year data collections for 2024-25, scheduled to be completed by January 2026 and expected to provide minimal changes to this report. The 2025-26 values reflect data available as of November 1, 2025, as submitted by the institutions. These numbers are subject to change since student applications can be approved throughout the year and Fall awards can be made retroactively. The institutions used point-in-time data for Fall 2025 to estimate program usage for the year. An update will be collected at end of the year.

During the program's seven-year growth period, the percentage of growth has declined steadily; however, this is primarily due to the increasing base as we measure changes year-over-year. More informatively, the program's incremental growth increased each year for six years, as demonstrated by Table 2 and Chart 1 below. Even

if incremental growth continues to fall each year, the program could exceed \$200 million by the end of the biennium.

It is not known how long the growth pattern will continue. The program may experience a modicum of regression in the future, but each year of growth represents a possible new floor. Growth factors include, but are not limited to, an increase in eligible families, increase in the percentage of these families having a student enrolled in a Virginia public institution and increases in covered costs. The Commonwealth has a commitment to continue to be an attractive destination for veteran families. To the extent that program awareness is a factor, the VMSDEP-related events of 2024 have ensured widespread awareness of the program within the Commonwealth.


