Dear Chairs Lucas and Watts,

Pursuant to Va. Code § 58.1-439.27(B), the Virginia Department of Education ("the Department") is required to report to the Chairs of the Senate and House Finance Committees the list of scholarship foundations that received donations for which tax credits were issued under the *Education Improvement Scholarships Tax Credits Program*. This report is based on donations made during the twelve-month period ending June 30 (i.e., state Fiscal Year 2025).

During Fiscal Year 2025 (FY25), there were a total of 35 scholarship foundations approved by the Department to participate in the *Education Improvement Scholarships Tax Credits Program* (to obtain approval, a scholarship foundation must submit a completed application along with all required supporting documentation). Of the approved scholarship foundations, 33 received qualified donations for which tax credits were issued. During FY25, a total of 5,336 scholarships were reported.

The following table shows the number of tax credits issued for eligible donations and the total number of scholarships awarded in FY25 as reported by the approved scholarship foundations. Under Va. Code § 58.1-439.28 A, scholarship foundations must disburse at least 90 percent of donations they receive during the twelve-month period ending on June 30 by the following June 30. As a result, the number of scholarships awarded during FY25 may include scholarships funded from donations made in the prior year.
