Commonwealth Aviation Fund Report to the General Assembly

Executive Summary

Item 425 C.1 through C.2, enacted by Chapter 725 of the 2025 Session of the General Assembly (2025 Appropriations Act), modified the distribution of entitlement and discretionary funds (Appendix A) and airport classifications (Appendix B) in the Commonwealth Aviation Fund (CAF) for FY2026. These changes conform to current practice, overriding the current statutory distribution of CAF funding under Code of Virginia §33.2-1526.6 (Statutory CAF Distribution). Further, paragraph C.3 of Item 425 directed the Virginia Department of Aviation (DOAV) to submit to the chairs of the House Appropriations and Senate Finance and Appropriations committees a report addressing:

- the amounts each airport in the Commonwealth is to receive under the updated allocations pursuant to paragraphs C.1 through C.2 of Item 425
- previous allocations of the Commonwealth Aviation Fund to each airport in the Commonwealth dating back to FY2020, and
- recommendations on how to best allocate the Commonwealth Aviation Fund in future years to ensure the financial health of all airports in the Commonwealth.

This report and the recommendations herein have been prepared in response to Item 425 C.3.

The Commonwealth Aviation Fund (CAF), which receives 1.5% of the Transportation Trust Fund every year, provides funding for capital planning and engineering projects that support airport facility development at the 65 public-use airports in Virginia. Formulas in Code of Virginia §33.2-1526.6 establish how the CAF is allocated for entitlement and discretionary funding. Since FY2021, the CAF has experienced significant growth due to increased revenues from the Commonwealth Transportation Fund and, by default, the Transportation Trust Fund which receives 49% of Commonwealth Transportation Fund revenues every year. While adequate for many years, the Statutory CAF Distribution more recently has failed to align with airport needs and activity levels and failed to optimize the use of funds in the CAF.

Entitlement Funding: Under the Statutory CAF Distribution, each commercial service airport received \$2 million in entitlement funds¹ regardless of airport activity, passenger traffic, service area, or infrastructure need between FY2021 and FY2025. For example, in FY2025, both Richmond International Airport and Shenandoah Valley Regional Airport each received \$2 million in entitlement funds despite the fact that Richmond International Airport handles 300 times as many passengers. Under the new 2025 Appropriations Act CAF funding formula for FY2026, more entitlement funding is available to those airports with higher enplanement levels, i.e., entitlement funding is no longer capped and allocated to airports based on demonstrated need. Under the updated formula, MWAA is no longer capped at \$2 million but receives 6% of the CAF prior to all other allocations. All other Commercial Service airports receive entitlement funds corresponding to the airport's passenger activity. In FY2026, Richmond International Airport is expected to receive \$4.5 million; Shenandoah Valley Regional Airport is expected to receive \$1.4 million.

¹ While the entitlement funding formula was based on the percentage of enplanements for each airport to total enplanements at all commercial service airports, the formula also capped the entitlement funds any one airport could receive at \$2 million. Because of the growth of the CAF over the years, all airports eligible for entitlement funding eventually received the maximum \$2 million in entitlement funding despite their differing percentages of enplanements.

Discretionary Funding: Both Commercial Service and General Aviation airports are eligible to receive discretionary funding from the CAF for capital projects. Discretionary funds are allocated by the Virginia Aviation Board (VAB) for eligible project requests based on a competitive process. These discretionary funds support facility development, planning projects, and engineering projects. Through FY2025, the imbalances in discretionary funding levels have limited the Commonwealth's ability to sufficiently fund much-needed capital projects, especially at General Aviation airports. Under the FY2026 funding formulas and the new airport roles, discretionary funding is more balanced, ensuring a more fair and equitable opportunity to fund projects at General Aviation airports.

Restructured Airport Roles: Through FY2025, under the Statutory CAF Distribution, 85% of General Aviation airports competed for limited discretionary funding. As such, eligible projects at smaller airports went unfunded. Based on recommendations made in the FY2023 Virginia Air Transportation System Plan, airports were assessed and reclassified (Appendix A). This new structure reclassified larger General Aviation airports as Regional Business airports, while smaller General Aviation airports were reclassified as Community Business and Local Service airports. This new airport classification structure provides additional discretionary funding for growing General Aviation airports while protecting funding for projects at smaller airports.

State funds are an important resource for all airports and are a means to invest in infrastructure. Through the implementation of the new funding formulas and new airport roles for FY2026 in the 2025 Appropriations Act, all airport project funding needs were met in the first two rounds of discretionary funding allocations in the current fiscal year. The implementation of the new funding formulas and airport roles are proving successful in providing necessary funding to all airport classifications. DOAV recommends codifying these new funding formulas and airport roles set out in the 2025 Appropriations Act to address continued growth in revenues and better align CAF distributions with airport infrastructure needs.

Introduction

This document has been prepared in response to the reporting requirement set forth in paragraph C.3 of Item 425 of Chapter 725 of the 2025 Session of the Virginia General Assembly (2025 Appropriations Act). This report provides an overview of the Commonwealth Aviation Fund; information on the allocation of funds from FY2020 through FY2025; information on the allocation of funds in FY2026 under the new funding formulas and airport reclassification system; and legislative recommendations.

Commonwealth Aviation Fund Overview

The Commonwealth Aviation Fund (CAF) provides funding for capital planning and engineering projects that support airport facility development at public-use airports in Virginia. These capital projects include master plan studies, environmental studies, land acquisition, airside facility design and construction, and terminal building design and construction. The Virginia Aviation Board (VAB) allocates CAF resources to eligible airport sponsors based on project eligibility and a defined prioritization process. An airport sponsor is an entity that is legally, financially, and otherwise able to assume and carry out the certifications, representations, warranties, assurances, covenants, and other obligations required to meet Code of Virginia and VAB policies and agreements with the state for the airport(s) it sponsors.

The Commonwealth Airport Fund was created in 1986 as part of the Transportation Trust Fund under Code of Virginia §58.1-638 (Disposition of state sales and use tax revenue). The Commonwealth Airport Fund was the source for state entitlement and discretionary funding for Virginia's public-use airports, and formulas prescribed in Code determined the amount of funding available to airports based on their Virginia Air Transportation System Plan (VATSP) roles (Air Carrier, Reliever, or General Aviation airports).

Code of Virginia §33.2-1526.6 (Commonwealth Aviation Fund), created in 2020, updated the airport funding program and included formulas for the distribution of entitlement and discretionary funding based on the VATSP roles of Air Carrier (now identified in VATSP as Commercial Service), Reliever (now identified in VATSP as Regional Business), and General Aviation (now identified in VATSP as Regional Business, Community Business, or Local Service airports).

The Statutory CAF Distribution, updated in 2020, calls for the distribution of funds as follows:

- Any new funds in excess of the \$12.1 million base that are available for allocation by the Virginia Aviation Board shall be allocated as follows:
 - 40% as entitlement funding to Air Carrier airport sponsors, with allocations to airports determined by statutory formula (capped at \$2 million per sponsor),
 - 40% as discretionary funding distributed to Air Carrier and Reliever airport sponsors pursuant to an application process for specific projects, and
 - 20% as discretionary funding distributed to General Aviation airport sponsors pursuant to an application process for specific projects.
 - Metropolitan Washington Airports Authority (MWAA) was allocated a maximum of \$2 million per year.

In addition, each January 1, all unobligated discretionary funds are to be combined, and all eligible sponsors may apply for this funding for specific projects. MWAA is not eligible for discretionary funds.

As a result of the 2020 Omnibus Transportation Bill, the CAF realized a significant increase in funding from the Transportation Trust Fund (TTF). The CAF, which receives approximately \$35 million annually from the TTF, is the sole source for state entitlement and discretionary funding for airports. With the influx of increased transfers from the TTF, the Statutory CAF Distribution fails to equitably distribute entitlement funds based on passenger activity and places restrictions on the discretionary funding available to the General Aviation airports. The Statutory CAF Distribution fails to effectively address funding needs at public-use airports in the Commonwealth. For example, the majority of available discretionary funds were allocated to the Commercial Service airports and eight General Aviation airports, previously classified as Reliever airports. Commercial Service airports are required to utilize their entitlement funding before requesting additional discretionary funds. This created a surplus in the larger discretionary fund, while leaving inadequate funding for the remaining 49 General Aviation airports in the General Aviation discretionary fund. Moreover, all Commercial Service airport entitlements were immediately extended to the maximum of \$2 million per airport, regardless of airport activity levels and associated capital needs.

Funding Participation

The state may participate in the funding of a project with an airport sponsor as part of a federally funded or a state-funded project. A federally funded project is funded with monetary participation by one or more federal agencies, the Commonwealth of Virginia, and the airport sponsor; a state-funded project is funded with monetary participation by the Commonwealth of Virginia and the airport sponsor. VAB policy requires that sponsors eligible for federal funding maximize the availability and use of federal funding. In addition, the Appropriations Act provides that DOAV is to match federal funds to the maximum extent possible. Commonwealth Aviation Funds, both entitlement and discretionary funds, are used as a state match for federal projects as well as state and local projects where federal funds may not be available. Of the 65 public-use airport sponsors in the state, 18 sponsors are not eligible to receive federal funding due to their lower activity levels and limited facilities and services.

For most federally funded projects, the state and the sponsor will each fund a share of eligible costs not covered by federal funding. Federal funding is available under the Airport Improvement Plan (AIP) programming or under special programming, such as the Infrastructure Investment and Jobs Act (IIJA). VAB policy allows state discretionary funds to be used to match available federal funds at the rate of 80% of the non-federal share of eligible project costs. For state-funded projects, the state's participation rate varies depending on the type of project; however, the state participation is usually 80% or 90% of the eligible project costs for state-funded projects, with the airport sponsor funding the balance of the project costs of 20% or 10% respectively.

Sponsor Eligibility

Airport sponsors must meet certain criteria to be eligible to receive CAF funding for capital projects. Some criteria are governed by the Code of Virginia and regulations and some are governed by VAB policy. The criteria include, but are not limited to:

- submission of an annual certification of financial responsibility in accordance with Code of Virginia §5.1-88.7,
- submission of an annual based aircraft survey in accordance with Virginia Administrative Code 24VAC5- 20-350,
- submission of an annual self-reporting of state aviation funding received in accordance with Code of Virginia §5.1-2.2:4, and
- maintenance of a current, board-approved entitlement utilization report and plan, which provides

an annual accounting of the previous fiscal year's state entitlement fund expenditures and plans for the use of entitlement funds for the new fiscal year, in accordance with Code of Virginia §5.1-2.2:3B.

The VAB requires a sponsor to have a current six-year Airport Capital Improvement Plan (ACIP) on file with DOAV to be eligible to receive state entitlement or discretionary funds. An ACIP identifies, phases, and prioritizes projects needed for airport facility development. This process ensures that funds are utilized for the highest needs and for projects that align with the goals of the approved masterplan for the airport and the priorities identified in VATSP.

The VATSP is a statewide system plan that incorporates strategic development and enhancement of airport facilities with the preservation and maintenance of existing airports; it also guides the development of new airports and examines the aviation needs of Virginia's communities. The VATSP has used airport roles to identify needs and solutions for similar airports. The roles are based in part on function and primary economic role, with consideration for types of communities served, and facilities and services, such as fuel and hangars, and approach capabilities. Prior to 2023, the roles were Air Carrier, Reliever, General Aviation Regional, General Aviation Community, and Local Service.

During the 2023 update of the VATSP, DOAV reclassified airports to better align with industry standards and the airport's role within the community and state aviation system, and to group airports with similar needs. DOAV used objective criteria to identify which airports would be grouped into the new roles of Commercial Service, Regional Business, Community Business, and Local Service Airports. The criteria included commercial airline service, eligibility to receive federal funding, runway length, fuel availability, and number of based aircraft.

The change in airport roles is summarized below. Details are provided in Table 1 (Appendix C).

Allocation of Commonwealth Aviation Funds Prior to FY2026 (Pursuant to Statutory CAF Disbursements under Code of Virginia §33.2-1526.6)

Entitlement Funds

State entitlement funds are allocated annually to sponsors of airports with scheduled air carrier service in accordance with Code of Virginia §33.2-1526.6. This allocation is based on each airport's enplanements as a percentage of all Air Carrier airport enplanements within the state during the previous calendar year. Code of Virginia §33.2-1526.6B1 specifies that no Air Carrier airport sponsor shall receive less than \$50,000 nor more than \$2 million in state entitlement funds per year.

Entitlement Allocation Process

DOAV distributes entitlement funds to Air Carrier airport sponsors in October, January, April, and June of each fiscal year. The amount of each payment is a quarter of the sponsor's annual allocation.

Entitlement Allocation Summary FY2020 through FY2025

The entitlement allocations distributed to air carrier airport sponsors in FY2020 through FY2025 are summarized below. Details of these allocations are provided in Table 2 (Appendix C).

Discretionary Funds

Code of Virginia §33.2-1526.6.B.2 provides funding for allocations to Air Carrier, Reliever, and General Aviation airports on a discretionary basis to fund capital projects. The VAB considers requests for discretionary funding at its quarterly meetings in August, November, February, and May.

For the first six months of each fiscal year, sponsors of Air Carrier and Reliever airports apply for the discretionary funds designated under §33.2-1526.6.B.2.a(1), and sponsors of General Aviation airports apply for funds designated under §33.2-1526.6.B.2.a(2). Beginning on January 1 of each year, all eligible sponsors (Air Carrier, Reliever, and General Aviation airports) may apply for the unobligated discretionary funds under §33.2-1526.6.B2b.

Discretionary Allocation Process

To receive discretionary funds, airport sponsors request discretionary funds from the VAB and compete with other airport sponsors for funding; state discretionary funds are not automatically allocated like state entitlement funds.

When a sponsor is ready to move forward with a project from its ACIP, the sponsor submits a request for VAB consideration. DOAV evaluates the request for compliance with sponsor and project eligibility and individual project request merits. DOAV also uses a project priority system to objectively prioritize statewide needs so that financial resources can be allocated to the highest priority projects that provide the most benefit to the Commonwealth. This priority system includes scoring for project purpose, such as safety or capacity; situational considerations, such as the availability of federal funds; and airport activity numbers for operations, enplanements and based aircraft. The prioritization system is part of the VAB and DOAV policies and processes which were developed and refined to advance aviation projects that are ready for implementation and will provide the most benefit to the Commonwealth

To carry out this process, DOAV presents eligible projects to the VAB for its consideration. The VAB then approves or disapproves of these projects; their approval of a project funding request constitutes the allocation of funds. The VAB may disapprove project requests due to unmet eligibility criteria, incomplete technical elements of the project request, or the lack of available state funding.

Discretionary Allocation Summary FY2020 through FY2025

A summary of discretionary funds allocated in FY2020 through FY2025 is below. Details of the allocations per airport for each fiscal year are provided in Tables 3 through 8 (Appendix C).

The allocation amounts and number of projects per year varied for several reasons, including, but not limited to the following:

- For many sponsors, funds for their local matches were not available in the earlier fiscal years due to financial impacts resulting from COVID.
- In Federal Fiscal Years 2020 and 2021, the Federal Aviation Administration (FAA) offered eligible airport sponsors federal funding grants utilizing the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) and AIP funding. This funding was combined to provide 100% federal funding for projects, so state matching funds were not needed.
- Beginning in FY2023, airport sponsors eligible for federal funding began using funds allocated through the FAA under the Infrastructure Investment and Jobs Act (IIJA). Sponsors requested state funds to match those federal funds. However, due to the large costs of many projects, most airport sponsors chose to carry over their annual IIJA allocations until the later years of this report's focus period to reach the funding levels needed for their projects.

Allocation of Commonwealth Aviation Funds in FY2026 (New Funding Formula Pursuant to the 2025 Appropriations Act)

When determining available allocations for FY2026 entitlement and discretionary aviation funding, DOAV used the funding formulas established in the 2025 Appropriations Act in combination with the airport role changes in the 2023 VATSP. While the allocation amounts changed, the allocation processes did not change for entitlement and discretionary allocations.

The estimated FY2026 CAF funding was calculated as 1.5%, or approximately \$37.1 million, of the Transportation Trust Fund. From this amount, 6% was allocated to MWAA pursuant to Paragraph C.1 of Item 425 as entitlement funds. Of the remaining funds, 50% was allocated for entitlement funds and 50% was allocated for discretionary funds.

Entitlement Allocation

As MWAA receives 6% off the top of the CAF for entitlement funding, Reagan National and Dulles airports are not included in this entitlement calculation. For FY2026, each Commercial Service airport's entitlement allocation corresponds to that airport's percentage of total enplanements. That percentage is then multiplied by the total entitlement fund balance to calculate each airport's share. Under the 2025 Appropriations Act, no Commercial Service airport sponsor shall receive more than 25% or less than 8% of the funds allocated as entitlement funds. The calculated FY2026 distribution of entitlement funds to Commercial Service airport sponsors is on the following page.

Under the 2025 Appropriations Act funding formula, the annual entitlement funding for five Commercial Service airport sponsors increased while the annual entitlement funding for three Commercial Service airport sponsors decreased. Under the Statutory CAF Distribution, all Commercial Service airport sponsors were receiving the maximum entitlement amount of \$2 million each year from FY2021 through FY2025. The airport sponsors receiving increased entitlement funds have seen significant growth in enplaned passengers over the period of this report. Those sponsors receiving less entitlement funding have not experienced the same level of growth. The new funding formula is directing entitlement funding to the airports based on demonstrated growth and need, ensuring a distribution of funds that is more aligned with activity levels associated with passenger enplanements. Passenger enplanements at Virginia's Commercial Service airports from CY2021 through CY2024 are below.

Discretionary Allocation

Under the 2025 Appropriations Act funding formula, of the remaining CAF (after the entitlement allocation to MWAA and the other Commercial Service airports), 50% is allocated as discretionary funds. For the first six months of FY2026, 40% of those discretionary funds is to be allocated for the 35 sponsors of Commercial Service and Regional Business airports, excluding MWAA facilities, and 10% is to be allocated for the 31 sponsors of Community Business and Local Service airports. For the second six months of FY2026, the remainder of the discretionary funds (following allocations during the first six months of the fiscal year) shall be made available for all eligible airports, with the exception of MWAA.

At the first quarterly VAB meeting of FY2026, held in August 2025, all requested needs were met with \$18.2 million in discretionary funds available. Of the \$18.2 million available, \$4.8 million was allocated.

Details of the discretionary allocations per airport role for the first quarter of FY2026 are below. A detailed breakdown of the discretionary allocation is in Table 9 (Appendix C).

Recommendations for Future Allocations

Previous funding formulas worked well when fewer dollars were going into the CAF each year. However, through the growth of Virginia's airport system and substantial increases in revenues resulting from the 2020 Omnibus Transportation Bill, funding levels for the CAF today far exceed the funding levels when the Commonwealth Airport Fund was first set up in 1986. As a result, an imbalance in funding exists which does not align with the original intent to distribute funding to Commercial Service airports in proportion to enplanements and provide for strategic investment in General Aviation airports based on their role in the state's system and activity levels.

DOAV recommends that the CAF funding formula established in the 2025 Appropriations Act for FY2026 be codified to allow funding for all airport roles to grow as revenues increase. This allocation recommendation better aligns funding with passenger counts and utilizes updated airport classifications to better align with VATSP goals, activity levels, and associated infrastructure needs.




