This report is being submitted in compliance with § 23.1-401.1 (D) of the Code of Virginia. This letter/report details Old Dominion University's implementation of § 23.1-401.1 entitled "Constitutionally protected speech; policies, materials, and reports; report." During this reporting cycle, we have reviewed policies to be updated based on the University policy review schedule. This year, we continued to promote our freedom of expression resource website to inform our student body. Students were also provided information and resources regarding freedom of speech as we continue to promote the use of our freedom of expression website. Our freedom of expression team meets monthly to assess campus need and determine opportunities for education. We continue to provide platforms for students to express their views on topics involving politics and social justice.

Specifically, the following measures have been taken during the most recent reporting period ending December 1, 2025, to adhere to the above-referenced law:

- Maintain a university website to support Speech and Activism and direct students to relevant resources: <https://www.odu.edu/student-campus-life/free-speech>
- Provided all students with information on freedom of expression and a link to the website with free speech resources for students.
- Sent an email to all students encouraging them to exercise their right to free speech, direct them to our online resources, and provide them with a contact email to communicate with directly.
