AGRICULTURAL LAND IN
FOREIGN OWNERSHIP**

EXECUTIVE SUMMARY

Chapters 765 and 796 of the 2023 Acts of Assembly established the Foreign Entities and Property Ownership Law (Va. Code § 55.1-507 et seq.) (Law), which, in part, requires the Virginia Department of Agriculture and Consumer Services (VDACS), on or before July 1 of each year, to publish a report regarding foreign ownership of agricultural land within the Commonwealth.

As of December 31, 2024, Virginia has a total land area of 25,340,160 acres, 18,789,439 of which are privately-held agricultural land. Of the 18,789,439 acres of privately-held agricultural land, 283,490 acres are foreign-held agricultural land consisting of 661 parcels across 83 Virginia localities. These foreign holdings comprise only 1.5 percent of all privately-held agricultural land in Virginia in 2024. This is a 4.8 percent increase in the total acreage of foreign-held agricultural land compared to December 31, 2023.

Notably, dispositions of both agricultural and non-agricultural foreign-owned landholdings in Virginia in both 2023 (20,384 acres) and 2022 (18,976 acres) far outpaced those in any of the past 10 years. Before 2022, annual dispositions did not exceed 6,920 acres in any year and were often negligible or zero. However, that trend reversed again in 2024 with acquisitions of land remaining steady while dispositions decreased significantly (4,486 acres). In 2024, forestland holdings increased by 9,367 acres (5 percent), continuing a multi-year trend of strong foreign interest in timberland. Forestland remains the largest category of foreign-owned agricultural land in Virginia. Foreign ownership of all other types of agricultural land increased by a moderate amount in comparison.

The following are the acres of agricultural land and non-agricultural land in Virginia owned by foreign investors as categorized by **USDA's Report 2 – U.S. Agricultural and NonAgricultural Landholdings (Acres) by Country of Foreign Investor and by State and County as of December 31, 2024**: Canada (62,590), Germany, (44,768), United Kingdom (36,339), Netherlands (9,523), Italy (2,253), and All Others (138,331). Of the 138,331 acres categorized under "All Others," 4,654 acres are landholdings owned by Chinese investors, representing approximately 3.4 percent of the agricultural and non-agricultural land attributed to this category and 1.6 percent of the total foreign owned agricultural and non-agricultural land in Virginia. 194,945 acres of land in Virginia owned by foreign investors are used as forestland, 45,027 as cropland, 26,382 as pasture, 17,136 as other agricultural land, and 5,654 as non-agricultural land.

VDACS is not aware of any information regarding the extent of or any recent changes in foreign ownership of energy production, storage, or distribution facilities in the Commonwealth.

VDACS does not recommend any legislative, regulatory, or administrative policy changes in light of the information in this report.

OVERVIEW

Chapters 765 and 796 of the 2023 Acts of Assembly established the Foreign Entities and Property Ownership Law (Va. Code § 55.1-507 et seq.) (Law), which, in part, requires the Virginia Department of Agriculture and Consumer Services (VDACS), on or before July 1 of each year, to publish a report on certain reporting requirements on VDACS's website and to deliver copies of such report to the Governor, the General Assembly, and the Chairmen of the Senate Committee on Agriculture, Conservation and Natural Resources and the House Committee on Agriculture, Chesapeake and Natural Resources.

Based on the reports submitted to VDACS pursuant to the federal Agricultural Foreign Investment Disclosure Act, 7 U.S.C. § 3501 et seq., and other information VDACS, at its discretion, deems appropriate, VDACS is required to compile an annual report in consultation with the appropriate state agencies and boards for each calendar year containing all of the following, if available:

1. The total amount of agricultural land that is under foreign ownership;
2. The percentage change in foreign ownership of agricultural land in the Commonwealth for each year over the prior 10 years;
3. The purpose for which foreign-owned agricultural land in the Commonwealth is being used currently. To the extent such information is available, the Department shall also include any significant recent changes or trends in the uses of foreign-owned agricultural land in the Commonwealth;
4. With the assistance of relevant state agencies, information regarding the extent of, and any recent changes in, foreign ownership of energy production, storage, or distribution facilities in the Commonwealth to the extent such information is available; and
5. Any legislative, regulatory, or administrative policy changes the Department recommends in light of the information in this report.

REPORTING

Background and definitions

The U.S. Department of Agriculture (USDA) disseminates an annual report on foreign holdings of U.S. agricultural land as required in the Agricultural Foreign Investment Disclosure Act of 1978 (AFIDA). AFIDA requires any foreign person who acquires or transfers an interest in agricultural land to report the transaction to the Secretary of Agriculture within 90 days. AFIDA also requires reporting on land that either becomes or ceases to be agricultural land or if the ownership entity becomes or ceases to be a foreign person. Failure to comply with AFIDA will subject the foreign person or other entities

disclosed on the report to a civil penalty of up to 25 percent of the fair market value of the interest held in the land in question. According to the USDA Farm Services Agency *Foreign Holdings of U.S. Agricultural Land – through December 31, 2024*, (hereinafter “AFIDA Report”), foreign investors held an interest in 46.3 million acres of U.S. agricultural land (forest land and farmland) as of December 31, 2024, an increase of approximately 1.3 million acres from the December 31, 2023, report.

For the purposes of the AFIDA Report, “agricultural land” means “land in the United States used for forestry production and land in the U.S. currently used for, or, if currently idle, land last used within the past five years, for farming, ranching, or timber production, except land not exceeding 10 acres in the aggregate, if the annual gross receipts from the sale of the farm, ranch, or timber products produced thereon do not exceed \$1,000. Farming, ranching, or timber production includes, but is not limited to, activities set forth in the Standard Industrial Classification Manual (1987), Division A, exclusive of industry numbers 0711–0783, 0851, and 0912–0919, which cover animal trapping, game management, hunting carried on as a business enterprise, trapping carried on as a business enterprise, and wildlife management. Land used for forestry production means land exceeding 10 acres in which 10 percent is stocked by trees of any size, including land that formerly had such tree cover and that will be naturally or artificially regenerated.”¹

According to the AFIDA Report, the information required to be reported consists of:

- the legal name and address of the foreign person;
- citizenship, if an individual;
- if not an individual or a government, nature of the legal entity, including the entity's country of creation and principal place of business;
- type of interest;
- legal description;
- acreage;
- land use;
- purchase price or any other consideration given;
- intended use;
- where applicable, information about the representative of the foreign person;
- how the interest in the land was transferred;
- the relationship of the owner to the operator;
- type of rental agreement, if any; and
- the date the interest in the land was transferred;

In the case of a disposition, the party disposing of the interest is also required to give the legal name and address of the purchaser. Any change in the legal name or address of the foreign person and other entities disclosed on the report form must also be reported within 90 days of such changes.

Acreage in foreign ownership and percentage increase over a 10-year period

According to the AFIDA Report, 18,789,439 acres of Virginia's total land area of 25,340,160 acres is privately-held agricultural land. Of the 18,789,439 acres of privately-held agricultural land, 283,490 acres are considered to be foreign-held agricultural land. These 283,490 acres consist of 661 individual parcels across 83 Virginia localities. The following chart² shows the total acreage of foreign-held agricultural land, the proportion of Virginia's foreign-held to privately-held agricultural land, and the percentage increase from the previous year.

The total foreign holdings comprise a relatively small portion of total privately held agricultural land in Virginia, approximately 1.5 percent in 2024. This is a 13,085 acre, or 4.8 percent, increase in the total acreage of foreign-held agricultural land from December 31, 2023. This contrasts with the 1.4 percent decrease observed between 2022 and 2023, which was the only year in the past decade to see a decrease in foreign acquisition of agricultural land in Virginia.

Notably, dispositions of both agricultural and non-agricultural foreign-owned landholdings in Virginia in both 2023 (20,384 acres) and 2022 (18,976 acres) far outpaced those in any of the past 10 years. Before 2022, annual dispositions did not exceed 6,920 acres in any year and were often negligible or zero. However, that trend reversed again in 2024 with acquisitions of land remaining steady while dispositions decreased significantly (4,486 acres). In 2024, forestland holdings increased by 9,367 acres (5 percent), continuing a multi-year trend of strong foreign interest in timberland. The following are the acres of agricultural land and non-agricultural land in Virginia owned by foreign investors as categorized by **USDA’s Report 2 – U.S. Agricultural and NonAgricultural Landholdings (Acres) by Country of Foreign Investor and by State and County as of December 31, 2024**: Canada (62,590), Germany, (44,768), United Kingdom (36,339), Netherlands (9,523), Italy (2,253), and All Others (138,331) (*Appendix 1*). Of the 138,331 acres categorized under “All Others,” 4,654 acres are landholdings owned by Chinese investors, representing approximately 3.4 percent of the agricultural and non-agricultural land attributed to this category and 1.6 percent of the total foreign owned agricultural and non-agricultural land in Virginia. 194,945 acres of land in Virginia owned by foreign investors are used as forestland, 45,027 as cropland, 26,382 as pasture, 17,136 as other agricultural land, and 5,654 as non-agricultural land (*Appendix 2*).
