SUBJECT: Transfer & Treatment of Sexual Assault Patients by Virginia Hospitals

This report is submitted in compliance with subsection B of the Code of Virginia § 32.1-162.15:7, which states:

The Department shall report to the Governor and the General Assembly by December 1 of each year on:

- 1. The name of each hospital that has submitted a sexual assault patient treatment plan, sexual assault patient transfer plan, or pediatric sexual assault patient transfer plan in accordance with the requirements of this section and, for each hospital, the specific type of plan, the date on which the plan was submitted, and the date on which the plan was approved;*
- 2. The name of each hospital that has failed to submit a sexual assault patient treatment plan, sexual assault patient transfer plan, or pediatric sexual assault patient transfer plan in accordance with the requirements of this section;*

3. *The name of each hospital for which an inspection was performed pursuant to subsection A and for each such hospital, the date of such inspection, and whether the hospital was found to be in compliance with the provisions of the sexual assault patient treatment plan, sexual assault patient transfer plan, or pediatric sexual assault patient transfer plan for such hospital approved by the Department; and*
4. *For each hospital determined to be out of compliance with the requirements of the sexual assault patient treatment plan, sexual assault patient transfer plan, or pediatric sexual assault patient transfer plan for such hospital approved by the Department, whether a plan of correction was submitted in accordance with the provisions of subsection A.*

## EXECUTIVE SUMMARY

---

The Virginia Department of Health (VDH) is submitting this report in response to the legislative mandate in subsection B of Code of Virginia § 32.1-162.15:7, which requires VDH to annually submit to the Governor and General Assembly information regarding hospital compliance with the requirements of Article 8 (§ 32.1-162.15:2 *et seq.*) of Chapter 5 of Title 32.1 of the Code of Virginia. This includes data regarding submission to VDH of proposed hospital plans for the transfer and treatment of adult and pediatric sexual assault patients and hospital inspections related to compliance with approved plans. This report is due by December 1 of each year.

From July 1, 2023, to present:

1. Forty-seven hospitals submitted and received approval for adult sexual assault patient (SAP) transfer plans.
  - a. An additional thirteen hospitals submitted SAP transfer plans that were denied VDH's approval, and have not re-submitted their plans, with appropriate revisions, for VDH's review.
  - b. One hospital submitted and received approval for a SAP transfer plan for its freestanding emergency department but has not resubmitted an acceptable SAP transfer plan for the entirety of the hospital following VDH's denied approval.
2. Forty-seven hospitals submitted and received approval for pediatric sexual assault patient (PSAP) transfer plans.
  - a. An additional ten hospitals submitted PSAP transfer plans that were denied VDH's approval, and have not re-submitted their plans, with appropriate revisions, for VDH's review.
  - b. One hospital submitted and received approval for a PSAP transfer plan for its freestanding emergency department but has not resubmitted an acceptable PSAP transfer plan for the entirety of the hospital following VDH's denied approval.
3. Forty-nine hospitals submitted and received approval for SAP treatment plans.
4. Forty-two hospitals submitted and received approval for PSAP treatment plans.
  - a. One hospital submitted and received approval for a PSAP treatment plan for its freestanding emergency department but did not submit a plan for the entirety of the hospital.
5. Six hospitals were noncompliant with the plan submission requirements in that they failed to submit any plan for VDH's review and approval.
6. No hospitals were inspected for compliance with the requirements of Article 8 (§ 32.1-162.15:2 *et seq.*) of Chapter 5 of Title 32.1 of the Code of Virginia and their approved plan.

## INTRODUCTION

---

### REPORT MANDATE

Subsection B of § 32.1-162.15:7 of the Code of Virginia (Appendix A) requires the Virginia Department of Health (VDH) to annually submit to the Governor and General Assembly by December 1:

1. The name of each hospital that has submitted a sexual assault patient treatment plan, sexual assault patient transfer plan, or pediatric sexual assault patient transfer plan in accordance with the requirements of this section and, for each hospital, the specific type of plan, the date on which the plan was submitted, and the date on which the plan was approved;
2. The name of each hospital that has failed to submit a sexual assault patient treatment plan, sexual assault patient transfer plan, or pediatric sexual assault patient transfer plan in accordance with the requirements of § 32.1-162.15:7 of the Code of Virginia;
3. The name of each hospital for which an inspection was performed pursuant to subsection A of § 32.1-162.15:7 of the Code of Virginia and for each such hospital, the date of such inspection, and whether the hospital was found to be in compliance with the provisions of the sexual assault patient treatment plan, sexual assault patient transfer plan, or pediatric sexual assault patient transfer plan for such hospital approved by VDH; and
4. For each hospital determined to be out of compliance with the requirements of the sexual assault patient treatment plan, sexual assault patient transfer plan, or pediatric sexual assault patient transfer plan for such hospital approved by VDH, whether a plan of correction was submitted in accordance with the provisions of subsection A of § 32.1-162.15:7 of the Code of Virginia.

### 2025 GENERAL ASSEMBLY UPDATE

Chapter 491 of the 2025 Acts of Assembly updated the Code of Virginia regarding sexual assault reporting. Updates included changing the terminology of “sexual assault survivor” to “sexual assault patient,” removing the requirement to submit a transfer or treatment plan for outpatient surgical hospitals (OSH) by removing them from the definition of hospital in § 32.1-162.15:2, and removing the requirement for hospitals to enter into a memorandum of understanding with rape crisis centers. The legislation also repealed the Task Force on Services for Survivors of Sexual Assault and directs the Department of Criminal Justice Services to convene a work group to address sustainable funding for sexual assault medical forensic examinations and services. Due to these updates, terminology has been changed throughout this report regarding sexual assault patients and all of the plans previously submitted by OSHs have not been included.

### REPORT OUTLINE

Following the discussion of the report mandate, the report provides listings of which hospitals have submitted a plan for VDH’s review and the outcome of those plan reviews. The report then lists which hospitals have not submitted a plan for VDH’s consideration or have not submitted a plan that the entirety of the hospital. The report concludes with a summary of inspection activities for the enforcement of these requirements, dating from July 1, 2023 to the date of this report.<sup>1</sup>

**APPENDIX A – CODE OF VIRGINIA § 32.1-162.15:7**

---

**§ 32.1-162.15:7. Inspections; report required.**

- A. The Department shall periodically conduct such inspections of hospitals licensed by the Department as may be necessary to ensure that sexual assault patient treatment plans, sexual assault patient transfer plans, and pediatric sexual assault patient transfer plans are implemented in accordance with the requirements of this article.
- B. The Department shall report to the Governor and the General Assembly by December 1 of each year on:
  - 1. The name of each hospital that has submitted a sexual assault patient treatment plan, sexual assault patient transfer plan, or pediatric sexual assault patient transfer plan in accordance with the requirements of this section and, for each hospital, the specific type of plan, the date on which the plan was submitted, and the date on which the plan was approved;
  - 2. The name of each hospital that has failed to submit a sexual assault patient treatment plan, sexual assault patient transfer plan, or pediatric sexual assault patient transfer plan in accordance with the requirements of this section;
  - 3. The name of each hospital for which an inspection was performed pursuant to subsection A and for each such hospital, the date of such inspection, and whether the hospital was found to be in compliance with the provisions of the sexual assault patient treatment plan, sexual assault patient transfer plan, or pediatric sexual assault patient transfer plan for such hospital approved by the Department; and
  - 4. For each hospital determined to be out of compliance with the requirements of the sexual assault patient treatment plan, sexual patient transfer plan, or pediatric sexual assault patient transfer plan for such hospital approved by the Department, whether a plan of correction was submitted in accordance with the provisions of subsection A.
