RE: § 37.2-308 of the Code of Virginia

Pursuant to § 37.2-308, Data Reporting on Children and Adolescents, enclosed is the quarterly report for the period [Q4 FY 2024] for the total number of licensed inpatient acute care psychiatric beds and licensed psychiatric residential treatment beds for children and adolescents.

*A. The Department shall collect and compile the following data:*

- 1. The total number of licensed mental health inpatient psychiatric beds for children and adolescents; and*
- 2. The total number of licensed psychiatric residential treatment facility beds for children and adolescents.*

*B. The Department shall report this data on a quarterly basis to the Chairmen of the House Committee on Appropriations and the Senate Committee on Finance and Appropriations and to the Virginia Commission on Youth.*
