4. Jerry Lorenzo James shall undergo a substance abuse treatment evaluation within 60 days of his release from the Virginia Department of Corrections.

Jerry Lorenzo James agrees this release is binding on his heirs, assigns, agents, and estate. This condition shall not apply to actual innocence claims and does not prohibit petitioning for a Writ of Actual Innocence or an Absolute Pardon. Should the conviction be overturned, this condition shall not prohibit compensation for the wrongful conviction.

WHEREAS, Sgt. **Wesley Gonzalez Shifflett** was found not guilty by a Fairfax County Circuit Court jury of involuntary manslaughter on October 4, 2024. In the same trial, the jury convicted him of the reckless discharge of a firearm. Despite the Senior Probation & Parole Officer's recommendation against incarceration and supervised probation, on February 28, 2025, the court sentenced Sgt. **Wesley Gonzalez Shifflett** to five years' incarceration, with two years suspended, and an additional five years of probation; and

WHEREAS, equal justice under law is a cornerstone of our justice system. Equal justice rests upon the bedrock principle that similarly situated individuals receive proportionate punishment. This precept animates sentencing policies enacted into United States and Virginia law. To that end, Virginia's sentencing guidelines "achieve the goals of certainty, consistency, and adequacy of punishment with due regard to the seriousness of the offense, the dangerousness of the offender, deterrence of individuals from committing criminal offenses, and the use of alternative sanctions, where appropriate;" and

WHEREAS, the sentence imposed in this case does not reflect these principles. In fact, the sentencing guidelines for the more serious offense of involuntary manslaughter of which Sgt. **Wesley Gonzalez Shifflett** was acquitted recommend a period of probation/no incarceration or a term of up to six months; and

WHEREAS, I have exercised the executive clemency authority granted by the Constitution of Virginia with the discretion and deliberation this authority demands. In this case, equal justice, fundamental fairness, and the dictates of conscience command me to action;

NOW, THEREFORE, I, Glenn Youngkin, Governor of the Commonwealth of Virginia, in accordance with the authority granted to me under Article V, Section 12 of the Constitution of Virginia, do hereby grant executive clemency and commute to time served the sentence imposed by the court

upon Sgt. **Wesley Gonzalez Shifflett** in its entirety. Finally, nothing in this action should be interpreted to deny, impair, abridge, or supersede any and an appellate or other rights of Sgt. **Wesley Gonzalez Shifflett**.
